

**Fulfillment Fund PATH Scholars Policy - 2021**

Our goal is to support you on your path towards college graduation. In order to achieve that goal we need your support. Below you will find a set of requirements that if followed will help us achieve said goal.

**PATH Program Recipient Responsibilities**

As a Fulfillment Fund scholar you are required to:

- **Academic**
  - Student must be enrolled full time 12 units per quarter/semester. (\_\_\_\_\_) *Initials*
  - Student must maintain a term and overall GPA of above a 2.0 (\_\_\_\_\_) *Initials*
  - If quarter/semester GPA falls below a 2.0 for the:
    - **First time**, student is still eligible for incentives but must meet with College Success Team and complete Academic Action Plan (\_\_\_\_\_) *Initials*
    - **Second time**, student must complete an Academic Action Plan, schedule an additional check-in with FF, and show proof of receiving supplemental assistance to College Success Team (\_\_\_\_\_) *Initials*
    - **Third time**, student is not eligible for incentives, must meet with their FF advisor, and may be disqualified from the PATH Program (\_\_\_\_\_) *Initials*
- **Individual Communication**
  - Complete term (fall/winter/annual) check-in and all tasks on Gradsnapp: <https://connect.gradsnapp.com/fulfillment>. The term check-in information will be used to monitor student persistence. (\_\_\_\_\_) *Initials*
  - If the College Success team does not hear from you for one semester/quarter, you may be disqualified from the PATH Program (\_\_\_\_\_) *Initials*
- **Participation**
  - Complete 3 check-ins (Fall/Winter/Spring) per academic year with your FF Advisor (phone/in person/zoom) (\_\_\_\_\_) *Initials*
  - Participate in 2 scheduled webinars per term (Fall/Spring). If there is a conflict with the scheduled webinar you must contact College Success Team to discuss the conflict. (\_\_\_\_\_) *Initials*
  - Participate in Peer Mentoring. All students that attend a college where we offer Peer Mentoring are required to be part of our peer mentoring program. (\_\_\_\_\_) *Initials*
    - CSUDH, CSULA, CSUN, UC Berkeley, UCLA, UCM, UCR, UCSC, LACC, SMC
  - Mandatory participation in our virtual Career Expo on 11/04/2021 from 4 PM – 7:30 PM. Exceptions may apply to students who have class during that time. (\_\_\_\_\_) *Initials*

**Disqualification Policy**

Failure to adhere to the Responsibilities may jeopardize scholarship eligibility and may result in disqualification at the discretion of the College Success Team. (\_\_\_\_\_) *Initials*

**Leave of Absence Policy**

To maintain eligibility in the PATH Program during a school leave of absence and/or if you do not meet the program requirements you must:

- Complete Gradsnapp (fall/winter/spring/annual) check-in and all tasks assigned to you (\_\_\_\_\_) *Initials*
- Schedule an advisement session with the College Success Team (\_\_\_\_\_) *Initials*
- Complete the Fulfillment Fund Leave of Absence Form (\_\_\_\_\_) *Initials*
